On the basis, the Election Committee decided and the Chairman had published a notification on 8th July 2021 in the Club website and notice board for conducting the election on 23rd July 2021 and hope you all were came to know about this notification.

In democratic setup usually after the scrutiny of the nomination, the candidates should get sufficient time to interact with the members for canvassing the vote. But asper the above election notice published in the Club website and notice board only meager days are left for canvassing.
